GENERAL SUMMARY

Under the direction of the Working Electrical Foreman, responsible for the proper installation, operation and maintenance of the electric transmission and distribution system. Also related electrical facilities and equipment.

ESSENTIAL DUTIES AND RESPONSIBILITIES

Performs construction, operation and maintenance of both overhead and underground electric transmission and distribution systems. Including electrical substation construction and maintenance.

Performs the duties of an Equipment Operator/Groundman through a Lineman/ Serviceman/Crew Leader 1st Class..

Assumes the duties and responsibilities of the Working Electrical Foreman in their absence.

Assists in training personnel from Lineman Apprentice 1st through 4th year.

Ensures work performed in accordance with Utility Construction Standards used by Greendale Utilities, OSHA work rules and the APPA Safety Manual rules. Prepares reports related to vehicles and construction equipment ensuring are all operating safely and are in good repair.

Operates heavy equipment such as bucket trucks, derricks, trenchers, backhoes and other related tools.

Attends seminars and continuing education classes to enhance technical skills. Including participating and passing the 4th year apprentice school.

The employee is expected to wear safety items associated with work responsibilities.

Participates in service watch call out rotation.

Perform all other duties as required.

QUALIFICATIONS

KNOWLEDGE AND ABILITIES
