Assists in performing construction, operation and maintenance of both overhead and underground electric transmission and distribution systems. Including electrical substation construction and maintenance.

Performs the duties of an Equipment Operator/Groundman through a 1st year Lineman Apprentice.

Ensures work performed in accordance with Utility Construction Standards used by Greendale Utilities, OSHA work rules and the APPA Safety Manual rules.

Prepares reports related to vehicles and construction equipment ensuring are all operating safely and are in good repair.

Operates heavy equipment such as bucket trucks, derricks, trenchers, backhoes and other related tools.

Attends seminars and continuing education classes to enhance technical skills. Including participating and passing the 1st year apprentice school.

The employee is expected to wear safety items associated with work responsibilities.

Perform all other duties as required.

QUALIFICATIONS

KNOWLEDGE AND ABILITIES

High school education or equivalent required. Through knowledge and familiarity with principles and practices of electric power line construction and maintenance (including electrical substations) required. Strong verbal communications skills necessary in order to deal with a wide range of personalities both inside and outside the organization. Able to make informed immediate decisions in emergency or highly stressful situations. A valid Indiana driver's license is required and will need to obtain CDL within six months after starting apprenticeship. Graduate of Electrical Lineworker School desired.

PHYSICAL REQUIREMENTS

The physical activity expected is balancing, stooping, crawling, climbing, kneeling, reaching, standing, pushing, pulling, lifting, talking, and repetitive motions.

Must be physically, mentally and psychologically able to perform all of the required duties. Position requires physical strength, finger and limb dexterity, and mobility.

Must be able to lift weights of up to 90 pounds.
